#### Call to Order

Mayor A. Max Bacon called the meeting to order at 7:00pm.

#### 1. Invocation and Pledge:

Pastor Eldren Morrison (Shaw Temple A.M.E. Zion Church) delivered the Invocation and led the Pledge of Allegiance.

#### 2. Agenda Changes:

Mayor Bacon announced that Item 4A under Land Issues/Zonings/Annexations would be tabled to the December 3, 2018 meeting at the request of staff.

## 3. Mayoral Report:

Mayor Bacon reminded everyone of Election Day and encouraged everyone to vote. He then invited any candidates present to speak.

DeAnna Harris, candidate for State Representative for District 41 which covers parts of Smyrna and Marietta spoke encouraging everyone to get out and vote.

Jennifer Jordan, current State Senator for District 6 thanked Mayor and Council for their hard work and encouraged everyone to get out and vote.

The Mayor took a moment to speak of Judge Harris Hines who passed away unexpectedly on Sunday, November 4, 2018 in a car accident. Asked that everyone keep his family in their thoughts and prayers.

City Administrator Tammi Saddler Jones provided the background information for the variance hearings that were affiliated with the property located at 1741 Spring Street. PWH Engineering, Inc. is proposing to annex the existing building at 1741 Spring Street into the City of Smyrna to open a new pet grooming shop and veterinary clinic. The applicant requested several variances to convert the existing building from an office to a veterinary clinic/pet groomer. The subject property is 0.31 acres, zoned General Commercial, and is subject to the Spring Road Corridor Design District.

Mayor Bacon asked that the applicant step forward. He then announced the Public Hearing and asked if there was anyone in attendance who wanted to speak for or against the variances. No one was present to speak for or against the proposed variances.

Mr. Gunar Overbeck, the realtor representing the seller, then stepped forward and was sworn in by City Attorney Scott Cochran.

Councilmember Blackburn introduced Mr. Russell Martin, Senior Planner, who presented detailed information regarding the variances.

Mr. Martin stated that 1741 Spring Street is the address and explained that they want to annex in property which is zoned in Cobb County as General Commercial. The desire is to keep zoning the same. There are some stipulations included in the variances to keep everything in line with current codes and ordinances of the City. The conditions are as follows:

- 1. The applicant shall install a 10' evergreen landscape buffer along the rear and side property lines that abut residentially zoned or used property in accordance with Section 503 of the Zoning Ordinance.
- 2. The applicant shall install a 6' privacy fence along the rear property line.
- 3. Outside dog runs and kennels shall be prohibited on the subject property.
- 4. The accessory structure shall be sound proofed should any animals be kept in the building.

Survey of existing property as well as photos of the property in its existing condition were shown as well as adjacent properties to show context. Community Development believed that the setback and buffer encroachments would not adversely affect surrounding residents and can be mitigated through the implementation of zoning stipulations; therefore, staff recommended approval of the requested variances with the conditions already mentioned.

The Mayor asked if the applicant had agreed to meet all conditions. The representative for the applicant agreed on behalf of the applicant.

Mr. Overbeck presented the applicant's proposal per the Mayor's request. The property is currently used as a hope home for people with eating disorders. The owner wanted to change the property to a veterinarian, grooming and cat boarding facility. All adjacent property owners had no issues with the change. The applicant agreed to fully comply with all staff recommendations.

Councilmember Susan Wilkinson asked Mr. Martin for a detailed explanation of the sound proofing condition. She had concerns regarding the use of the accessory building and compliance with the City's noise ordinance.

Mayor Bacon concluded the public hearing.

She welcomed the property owners to the City but reiterated that there is a potential quality of life issue for those residing around the property.

Mayor Bacon noted that the owners could stay in the county and do what they are asking to do without the City having any control and again welcomed them to the City.

City Administrator Tammi Saddler Jones advised Mayor and Council as to the background on the Sustainability Resolution agenda item. Resolution 2018-10 is a resolution concerning sustainable programs in the City of Smyrna. It outlines the programs the City is currently doing for sustainability. It also indicates a willingness by the City to look into other programs that will increase the sustainability of the City. Staff recommended approval of the resolution.

Mayor Bacon stated that the item was co-sponsored by Councilmember Blackburn and Councilmember Welch.

Ms. Blackburn who brought the idea before the Council, spoke of how proud she is to be part of a City that is already sustainable and that will strive to continue finding ways to operate in a sustainable fashion. She also briefly spoke of the citizens group that call themselves Sustainable Smyrna.

Mr. Welch noted that the City is doing many things right in terms of sustainability and previous Councils paved the way for these programs.

Ms. Saddler Jones reviewed the background information and details relating to the resolution. As defined in the amendment to Sec 6-46 "Carry-in prohibited" of the City of Smyrna Code of Ordinances, the carry-out of alcoholic beverages is only authorized in areas that are designated as a Restaurant District by a resolution from Mayor and Council. This resolution revises the borders of the Smyrna Market Village Restaurant District to include the Veterans Memorial lawn, the arboretum and pond next to the Community Center, the roundabout along Village Green Circle, the fountain area near the Community Center, and the field between the Community Center and Atlanta Road. The new borders connect to the north side of the Smyrna Market Village Restaurant District borders outlined in RES 2018-04. Staff recommended approval of the resolutions.

Assistant City Administrator Scott Andrews explained that this resolution is an extension of the restaurant district that passed sometime back.

Mayor Bacon noted that 6B through 6E are all resolutions creating extensions of the restaurant districts throughout the City.

Councilmember Norton reiterated that this is an extension of the already successful restaurant district that was previously approved.
