LOCATION: 4105 NORTH COOPER LAKE ROAD

Notice is herewith published in accordance with the Charter of the City of Smyrna that application has been made by MCLANE CORPORATION to rezone property located in Land Lots 335 of the 17th District of the 2nd Section of Cobb County, Georgia from R-15 to RAD-Conditional.

**THERE WILL BE NO LAND USE CHANGE FROM SUBURBAN RESIDENTIAL.**

A hearing will be held before the Mayor and City Council of Smyrna at a regular meeting on February 17, 2014, at 7:30 p.m. in the City Hall Council Chambers, 2800 King Street, Smyrna, Georgia, 30081.

**LEGAL DESCRIPTION:**

All tract and parcel of land lying and being in Land Lot 335, 17th district, 2nd Section, Cobb County, Georgia and being more particularly described as follows:

Beginning at an iron pin found at the Land Lot corner common to Land Lot 334, 335, 386 and 387 and also being the TRUE POINT OF BEGINNING; thence leaving said Land Lot corner and turning and running along the Land Lot line common to Land Lot 334 and 335 the same line being the northern right-of-way of Plant Road (fifty-foot right-of-way) a bearing of S 89°55' 00" W for a distance of 623.4' to an iron pin found; thence leaving said Land Lot line and road right-of-way and turning and running along a bearing of N 36°02' 00" E for a distance of 470.47' to an iron pin found; thence turning and running along a bearing of S 80°25' 00" E for a distance of 59.62' to an iron pin found; thence turning and running along a bearing of S 79°55' 00" E for a distance of 298.0' to an iron pin found; thence turning and running along the Land Lot line common to Land Lot 335 and 386 a bearing of S 01°00' 00" W for a distance of 317.5' to an iron pin found at the Land Lot corner common to Land Lot 334, 335, 386 and 387 and also being the TRUE POINT OF BEGINNING; said tract containing 4.01 acres more or less.
