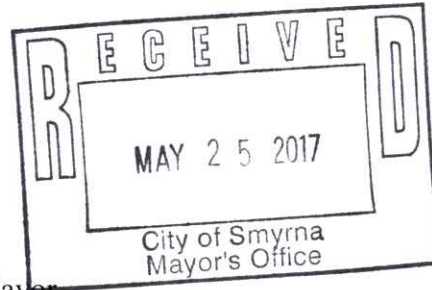

Dear Mayor Bacon:

Please note: this letter **supersedes** the previous letter of Intent to Object. The subject property is currently zoned R-20 and is within an area identified as Low Density Residential according to the Cobb County Future Land Use Map. The applications indicate the sites will be rezoned to RAD-Conditional, and be utilized for a single-family residential subdivision consisting of 15 detached units with a density of 3.58 units per acre.

Based on our HB 489 Intergovernmental Agreement, this is technically an objectionable request. The proposed city zoning category has not been previously agreed to as unobjectionable in the County Future Land Use category in which it is located. However, the proposed density will be below that which has been agreed to as unobjectionable. Based on that consideration this application could qualify as unobjectionable. After an opportunity for further consider and discussion we recognize that the applicant has responded to the previous objections by the County by redesigning the proposed development so that it complies with the intent of the criteria within the Agreement. As such, the response has been changed accordingly.

Additionally, we encourage the city to propose a modification to the exhibit in our HB 489 agreements to add the RAD district to the list of unobjectionable city zoning categories. This will assist in avoiding similar situations in the future.

In summary, please accept this letter that supersedes the May 8, 2017 Intent to Object as the County's formal notice of **non-objection** to the proposed annexation. The comments from the Cobb County Water System, Department of Transportation and Stormwater Management Division are attached for your consideration. **Water service for this parcel is provided by the existing CCWS water main in Fontaine Road.**

**Wastewater for the parcels can be treated at the South Cobb WRF where there currently is sufficient capacity. Permit issuances are subject to continued WRF compliance with EPD discharge requirements.**

**Because CCWS will continue to own and maintain water and sewer facilities in public rights-of-way and public easements, there would be no infrastructure loss.**

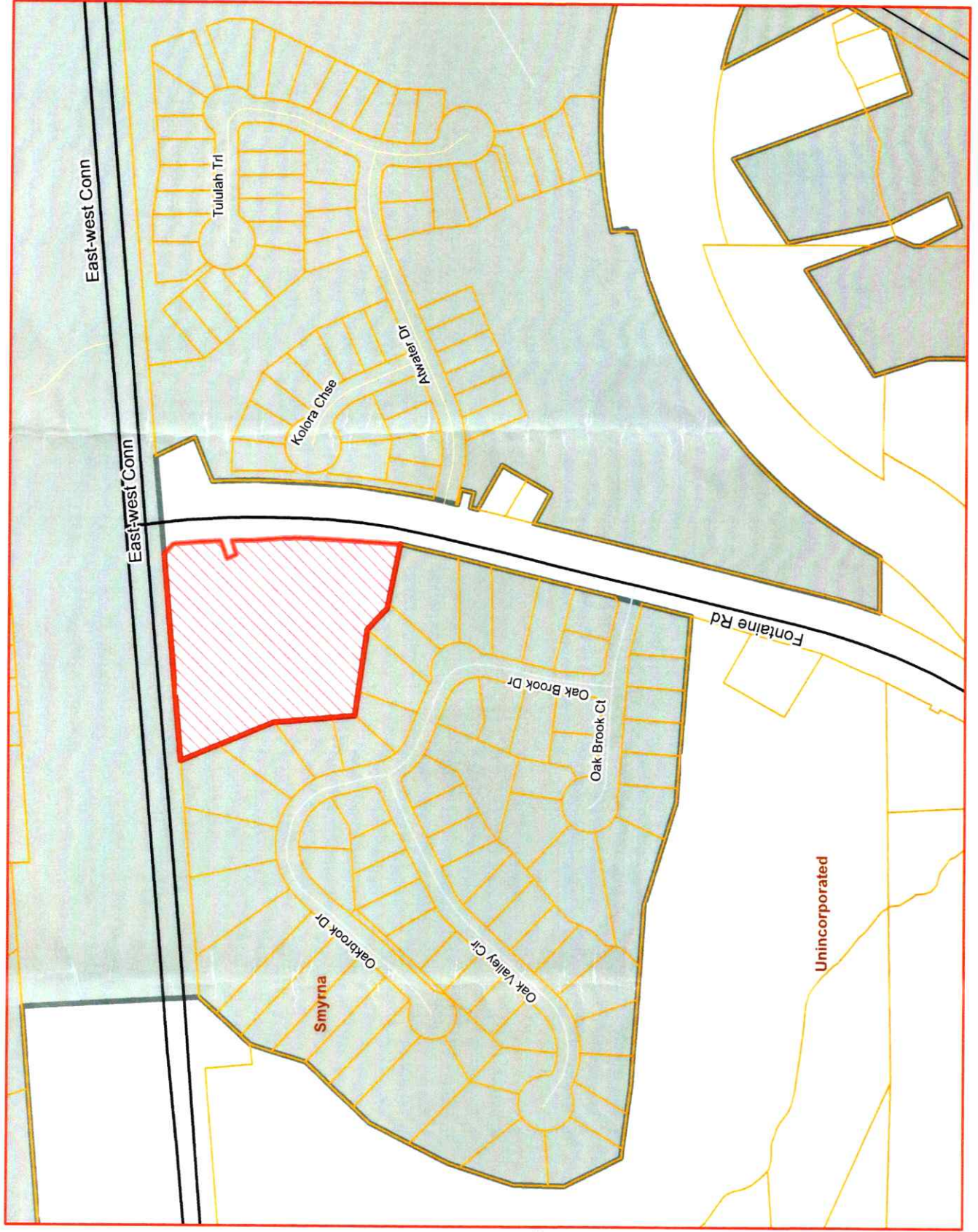
