Attached is the supplemental agreement with Windy Hill for the addition of the lights around the bridges that were not included in the original agreement. Based upon field discussions, a modification was made to the service point at the West Bridge, and at both bridges beyond each end (in the local access shoulders) and added two additional lights, one of each type. These are needed to help safe operations of these intersections, especially with the mid-ped crossings etc. This added 4x(145) and 4x(80) so a total of 8 additional lights.
