Appointment of Interim Environmental Services Director Julie Barwig to the permanent position of Environmental Services / Keep Smyrna Beautiful Director.

City Administrator Joe Bennett provided background information on Ms. Barwig and her contributions to the city thus far. Ms. Barwig previously served as the Coordinator for Environmental Services / Keep Smyrna Beautiful and upon the previous Director's resignation, was appointed as the Interim Director by Interim City Administrator Joseph Bennett. Ms. Barwig has served in this position for several months with recommendation from the Keep Smyrna Beautiful Board, City Administrator Joseph Bennett has brought her name to the Mayor and Council for approval into this permanent position. The Keep Smyrna Beautiful Board and staff recommend the appointment of Interim Environmental Services Director Julie Barwig to the permanent position of Environmental Services / Keep Smyrna Beautiful Director.

Appointment and swearing in of Keith Zgonc as the City of Smyrna Chief of Police as a result of Chief Joseph Bennett's appointment to the position of Smyrna's City Administrator.

Former Smyrna Police Chief and current City Administrator Joe Bennett spoke about Mr. Keith Zgonc and his experience working with him. He then provided additional background information. His 28 year career began in 1991 with the City of Smyrna. In February 2020, Deputy Police Chief Joseph Bennett was appointed and sworn in as Police Chief for the City. In October 2021, Chief Bennett was asked to serve as the Interim City Administrator after the resignation of Tammi Saddler Jones and after six months of service in this capacity, he was appointed and sworn in as the permanent City Administrator, leaving a vacancy in the Police Chief position. Chief Zgonc has previously served as Deputy Police Chief for the City of Sandy Springs and has completed a lengthy and thorough application, interview and background process. recommend him for the permanent position of Smyrna Chief of Police. Mayor and Council recommend the appointment and swearing in of Keith Zgonc as the City of Smyrna Chief of Police.

B. [ORD2021-05](#) Public Hearing - Approval of Ordinance 2021-05 for the Code Amendment to the City's Code of Ordinance - Sections 402 and 505 -

Home Occupation - City of Smyrna.

City Administrator Bennett read aloud the information relating to this agenda item. The Community Development Department reviewed Sections 402 and 505 of the City's Zoning Ordinance to bring the home occupation requirements inline with the current standards. In recent years, the radius letter requiring the neighbor signatures has become unnecessary and cumbersome to citizens looking to obtain a home occupation certificate. The proposed amendments include:

- 1) Amend Section 402.30 to remove sentences that allow emergency consultation or treatment by physicians, dentists, lawyers and the operation of one-chair salons;*
- 2) Removing subsection 505.12;*
- 3) Removing references to appearing in front of mayor and council;*
- 4) Updating language to reflect current standards; and*
- 5) Updating the order and the language of the home occupation conditions.*

Planning and Zoning Board approved on April 12, 2021 with a vote of 7-0. Community Development recommends approval of the following code amendments to Section 402 and 505 of the City's Zoning Ordinance.

Councilmember Tim Gould spoke about the importance of making it easier to allow those who work from home to do their business.

The public hearing was announced by Mayor Norton and no one came forward to speak.

The background information on this agenda item was read aloud by Mr. Joe Bennett. The proposed code amendments will move all variance requests and appeals of administrative decisions from the City's Code of Ordinances from the License and Variance Board and to the Mayor and City Council for final action. These variance requests include variances from the Alcoholic Beverage Ordinance, Property Maintenance Code, Stream Buffer Ordinance, Zoning Ordinance, Subdivision Regulations and Urban Design District. In addition, the proposed code amendments will rename the License and Variance Board to the License Board, which will just process licensing requests. Should the proposed code amendment be approved by the City Council, the variance requests will begin to be heard by the City Council at the May 3, 2021 Council Meeting. The proposed text amendments have been sent to the

City Attorney for review and comment. Community Development recommends approval of the proposed code changes related to the variance process.

Mr. Ihrig has been given a copy of the Alcoholic Beverage Ordinance and attended the mandatory alcohol awareness workshop. A background investigation conducted by the Smyrna Police Department failed to reveal information that would preclude the issuance of this license. Drew Ihrig has agreed to abide by the guidelines set forth by the City of Smyrna ordinance governing the sale of alcohol. Mr. Drew Ihrig spoke about his experience with catering and this business and how it seemed to be the ideal way to evolve within the field of event services.

The tour is scripted and performed by Atlanta Theatre-To-Go and is proposed to take place on Saturday, October 16 and Sunday, October 17, 2021 from 5:00 p.m. to 9:30 p.m. The tour will consist of three 45-minute walking tours of various downtown locations and one street closure - Memorial Place between Church Street and Atlanta Road, adjacent to the Smyrna Cemetery.

City Administrator Joe Bennett reviewed the background for this upcoming event. The Smyrna Arts Council is requesting permission for one street closing and approval for two days of street theatre on October 16 and 17, 2021 in the downtown, making use of Memorial Place, the Smyrna Cemetery, the pavilion across from City Hall as well as conduct three 45-minute guided walking tours each evening. This event was approved to take place in 2020 but was cancelled due to COVID-19/pandemic. The 2021 event is a first-time event in Smyrna, presented/managed by the Smyrna Arts Council, organized in conjunction with a professional theatre company (Atlanta Theatre-To-Go). Each tour is proposed to have a maximum of 30 people (25 preferred) with tickets purchased in advance or on-site and plans to post as "sold-out" when maximum for each 45-minute tour is achieved. For more information on Atlanta Theatre-To-Go, visit their website at www.atlantatheatreto.go.com. Staff recommends approval of this first-time street theatre event taking place over two evenings, highlighting Smyrna history and culture with street closings and event specifics as requested.
