City Administrator Tammi Saddler Jones presented the background information for this agenda item. This was for the approval to award RFP 20-016 Windy Hill Boulevard project to the reccommended bidder Baldwin Paving Company for the amount \$29,571.781.52. The City of Smyrna requested bids for the 2016 SPLOST Windy Hill Boulevard project (6) six bids were received. The lowest and responsive bidder was chosen based off the option of the City Of Smyrna utilizing precast wall panels and maintaining the Ashlar finish for the vehicle barriers. Public Works, Purchasing and Croy Engineering LLC after review and analysis of the six bids opened for the Windy Hill Boulevard project it is the recommendation to award the project utilizing the option of precast wall panels and maintaining the Ashlar finish for the vehicle barriers to Baldwin Paving Company for the amount \$29,571,781.52.

Councilmember Charles "Corkey" Welch made a motion to approve to award RFP 20-016 Windy Hill Boulevard project to the lowest and responsive bidder Baldwin Paving Company located at 1014 Kenmill Drive N.W.
