\$ IMPACT

ISSUE:

New application for privilege licenses for Gursha Ethiopian Cuisine for the sale of beer and wine (retail pouring). Gursha Ethiopian Cuisine is the owner and Genet Tenaye is the agent applicant. Gursha Ethiopian Cuisine desires a waiver of the distance requirement as listed in City Ordinance Sec 6-118 (600' from a school) as amended in City Ordinance 2015-09 which permits waiver of distance requirements for restaurants requesting a pouring license.

SUMMARY:

Genet Tenaye as the registered agent for Gursha Ethiopian Cuisine requests a privilege license for the sale of beer and wine (retail pouring) at 1651 Roswell Street.

BACKGROUND:

Genet Tenaye will be the registered agent, responsible for the sale of alcohol at the referenced location. Genet Tenaye has been given a copy of the Alcoholic Beverage Ordinance and attended the mandatory alcohol awareness workshop. (Certificate attached)

STAFF RECOMMENDATION:

A background investigation conducted by the Smyrna Police Department failed to reveal information that would preclude issuance of this license. Genet Tenaye has agreed to abide by the guidelines set forth by the City of Smyrna ordinance governing the sale of alcohol.

REQUESTED ACTION:

Approval of privilege licenses for the sale of beer and wine (retail pouring) for Gursha Ethiopian Cuisine with Genet Tenaye as the registered agent.

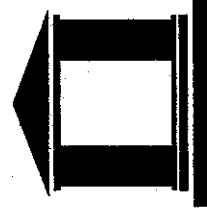



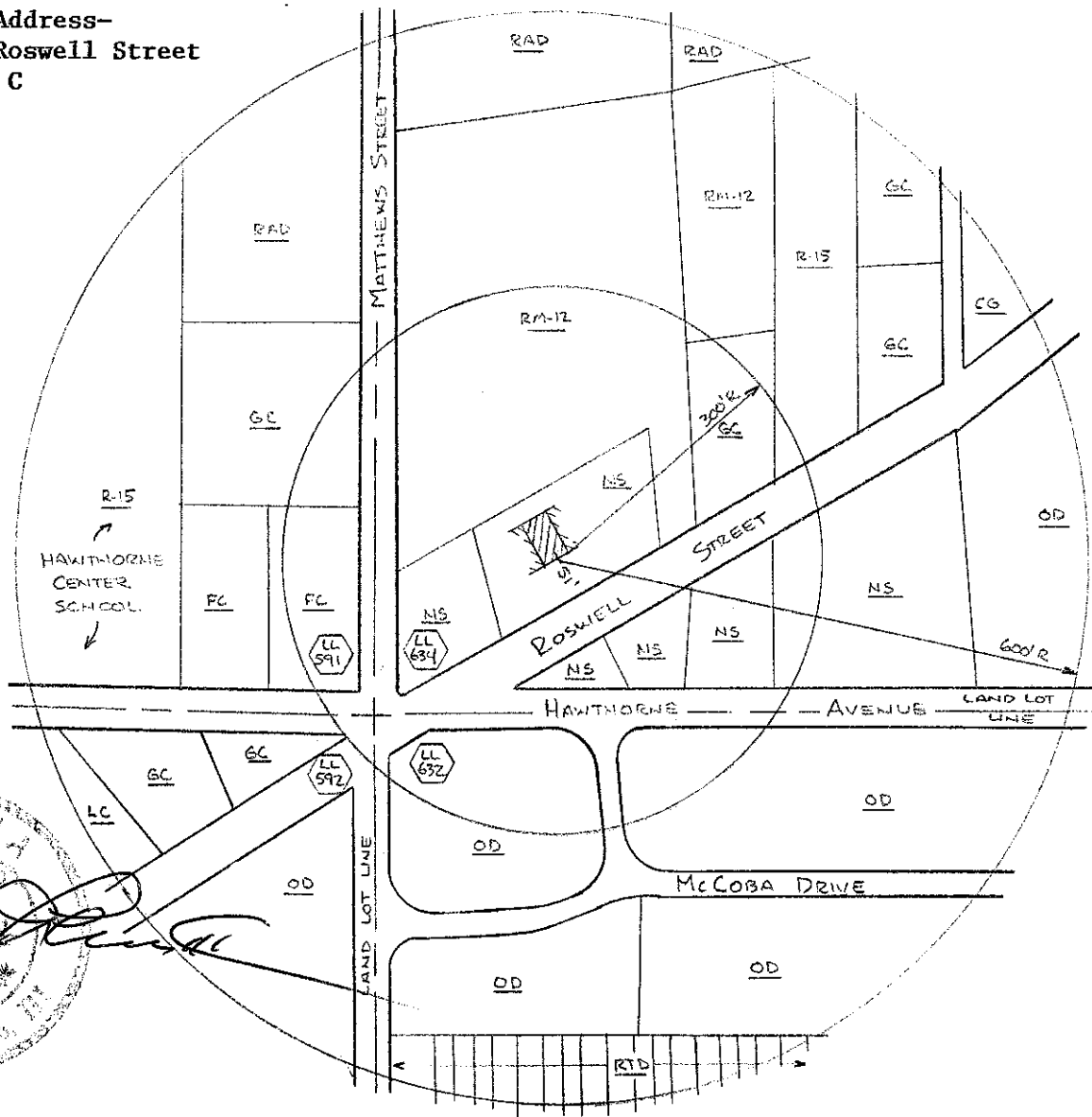

SECTION 1 DEFINITIONS

1.1 Shopping Center. The term "Shopping Center" means all that certain land and all buildings, improvements, equipment and facilities erected or to be erected thereon at 1651 Roswell Street, Smyrna, GA, as same may be altered, expanded or reduced from time to time.
