ISSUE:

Application for a change of agent for privilege licenses for beer and wine (retail package) for Smyrna Tapas LLC dba Smyrna Beer Market with Brandon Eugene King as new applicant. Previous agent was Kevin Drawe.

SUMMARY:

BACKGROUND:


