Dempsey, et al., recorded in Deed Book 231, page 278, in the said Clerk's office; thence running southerly along the east line of said property in Land Lot 810 so acquired by Mrs. Max Don Howell 500 feet, more or less, to the south line of Land Lot 810; thence running easterly along the line dividing Land Lots 810 and 811, 375 feet, more or less, to the northeast corner of property in Land Lot 811 conveyed to Argyle Realty Company by Isoline Campbell Howell individually and as Trustee for Richard Orme Campbell by deed dated December 1, 1948, and recorded in Deed Book 208, page 196, in the said Clerk's office; thence running southerly along the east line of the property so conveyed to Argyle Realty Company 665 feet, more or less, to the north side of the right-of-way of the Louisville £ Nashville Railroad, and running thence westerly, southwesterly, westerly and northwesterly along the northerly, northwesterly, northerly and northeasterly side of said Railroad right-of-way 3,500 feet, more or less, to the southeast side of Campbell Road at the point of beginning.
