#### 2. Call to Order

Mayor Pro Tem Derek Norton called the October 3, 2019 Committee of The Whole Board Meeting to order at 6:00 pm.

#### 3. I-285 Westside Express Lane Project - Arcadis

Mr. Tim Matthews (GDOT) and Shamir Poudel (Arcadis) presented to the Mayor and Council, and Department Staff members about the I-285 Westside Express Lane project backed by Governor Kemp.

This program of express lane projects will benefit drivers with the most travel time, and free up room for large trucks. This is a \$11 million program consisting of four major categories of express lane projects that all link together, and the Westside Express Lane project. Improvements will be made to the West interchange project at 285 & I-20 East & West, interstate widening jobs, and commercial vehicle project down on 75 South.

This is a long term project where the legislature made the funding decisions with GDOT and GRTA; State, Federal, and otherwise type money. This agreement was crafted to the GDOT agreement with Arcadis. The goal is to expand our express way system in our most congested corridors.

#### 4. Gordon Mortin - Belmont

Mr. Gordon Mortin and Mr. Tom Owens of Raymond James & Associates presented to the Mayor and Council, and Department Staff members on the Belmont Hills redevelopment refinance. We can redo the current agreement by refinancing through a bond on a short-term interest rate and pay off 8 years sooner. This will allow the City to reduce a 7 percent interest rate to 3.65 percent interest. The local bank the City has been working with for about 7 months now, requires a term sheet signed to confirm the City's partnership.

#### 6. Hefty Energy Bag - Janet Liberman

Presented by Janet Liberman (Director, Environmental Services-KSB) is a way to recycle hard to recycle plastics. This program is extended and funded by a Keep Cobb Beautiful grant. Smyrna residents have voiced that they want to participate in this program; there will be no cost to the City of Smyrna. Only curbside recycling pickup residents can sign up. Residents will receive a kit with four orange bags labeled "Hefty Energy Bag". Refill bags can be purchased at Kroger supermarkets at approximately \$8.00. Items that can be placed in the recycle bags are candy wrappers, chips bags, plastic cups, plastic utensils etc.; you cannot add items that go into regular recycling bags such as toys, glass, hoses, rope, rubber etc. The City Council is asked to approve the "MOU" to get the program started and education out to residents. The grant requires a minimum of 50,000 homes to qualify Smyrna.
