### **Design Assumptions**

- The design assumes that this new console will join the 5 existing consoles at the same dispatch center and hence no new connectivity required between the dispatch center and the Cobb County Master site.
- The design assumes that the Cobb County radio system will be at version 7.18 at the time of purchase. If the system has already been upgraded beyond 7.18 at the time of purchase, the equipment will need to be revised accordingly.
- The design does not include the interface of the proposed equipment to any E-911 or CAD systems, other than connection to E911 audio through the console headset. If City of Smyrna requires any additional interfaces into the CAD and/or E911 systems, Motorola can quote these upon request.
- The design assumes that City of Smyrna will be providing any infrastructure needed to support the operation of the MCC 7500 console positions.
