Dear Mayor Bacon:

This letter is in response to the petition for annexation referenced above. Due to the Board of Commissioners' upcoming meeting schedule, we are responding to the informal notification sent via email by city staff on November 12, 2019.

Please accept this response to the annexation proposal for 2320 Campbell Road. The subject property is currently zoned Neighborhood Retail Center (NRC) in the northern portion, and Office and Institutional (O&I) in the southern portion. The site is within an area identified as a Community Activity Center (CAC) according to the Cobb County Future Land Use Map. The application indicates that the site will be rezoned to Mixed Use Conditional (MU – C) for the development of 112 single-family townhomes and a 180-unit senior independent living facility. This application meets the criteria of the HB 489 Intergovernmental Agreement (IGA), except for exceeding the density by 0.19 dwelling units per acre. We encourage the City to work with the applicant to adjust the design of the site to avoid exceeding the maximum unit density per the HB 489 IGA.

In summary, please accept this letter as the County's formal **notice of non-objection** to the proposed annexation. Please see the attached comments from the Cobb County Water System and the Cobb County Department of Transportation. 

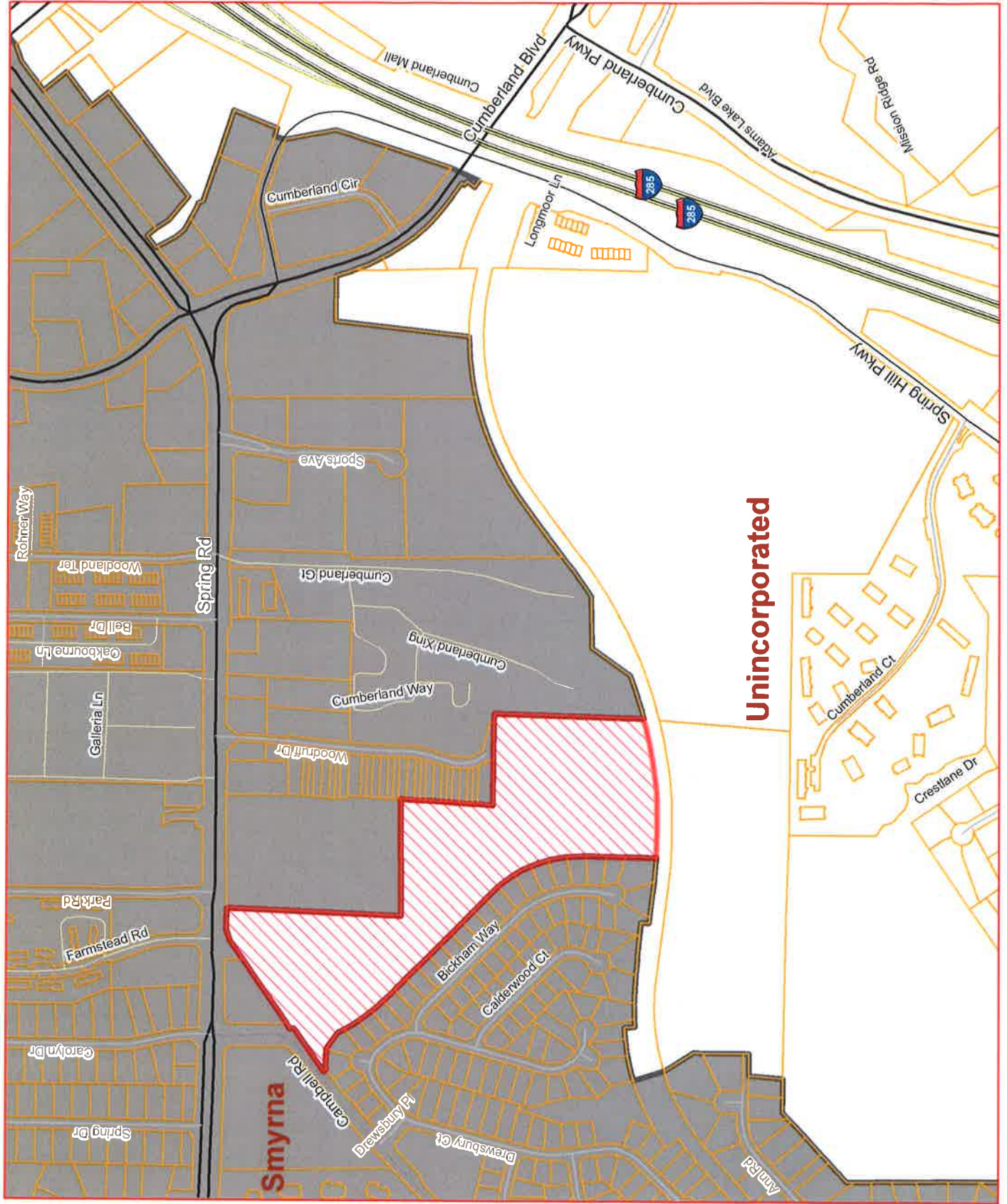
