Appeal the denial for a alcohol servers permit for Ellyn Waters

Assistant City Attorney Jeffrey Tucker swore in Ellyn Waters, the applicant, and Marla Gerber from the records department at the police department. Marla Gerber stated that a background check had been run on the applicant and the criminal background check revealed two pending charges that have not been adjudicated. Ms Waters stated her name and address. Jeffrey Tucker asked Ms. Waters if she disagreed with the testimony of Ms Gerber. Ms Waters stated that she has one pending felony and one pending misdemeanor charge. Ms. Waters came to appeal her denial to the board. She stated that it is her understanding that only the Mayor

and Council can approve the appeal. She stated that she works for Jim 'n Nicks in Smyrna. When her grace period for getting the alcohol server permit ended, she forgot to apply. She is in recovery and has been for several years. She is trying to work and pay her bills. This is her only job and she is currently busing tables. Public Works Director Scott Stokes asked if she was serving alcohol without a permit, and she stated that she had been until management brought to her attention management that she needed her permit. She holds a permit in the City of Atlanta and didn't expect to have a problem in Smyrna since she never had a problem in the past. Ms. Jones stated that due to her pending charges according to the ordinance, they have to postpone the decision and advised her that she can appeal her denial to the Mayor and Council at the next meeting.

A motion was made by Roy Acree to postpone the decision regarding 2014-137 for an appeal of the denial for an alcohol servers permit made by Ellyn Waters, seconded by Scott Stokes. Motion carried by the following vote:
