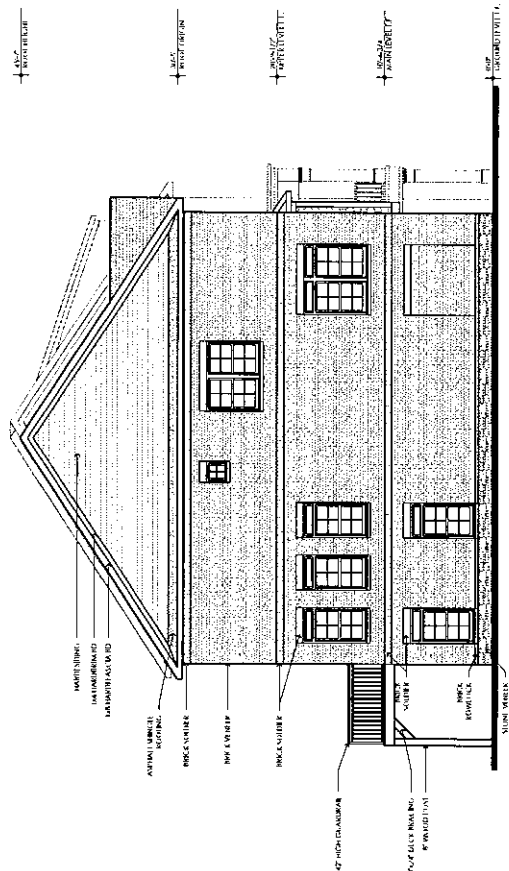

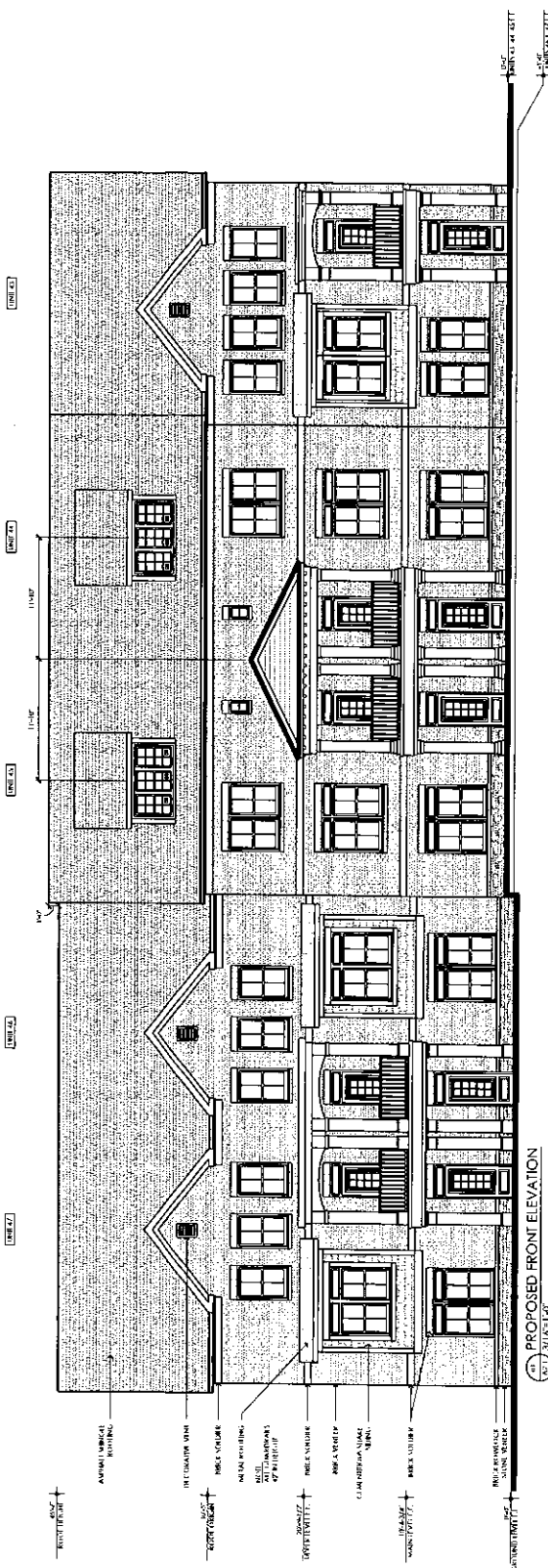

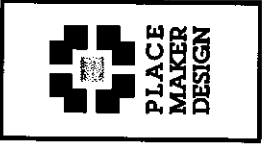

PROPOSED FRONT ELEVATION



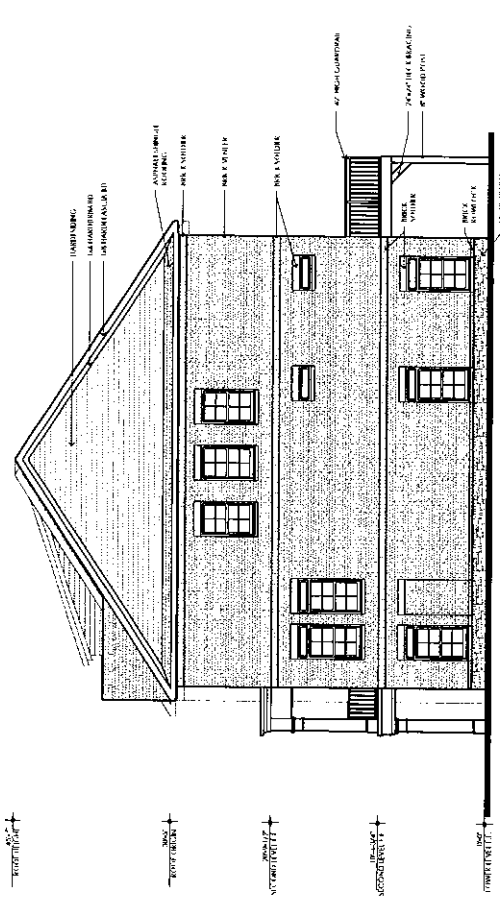

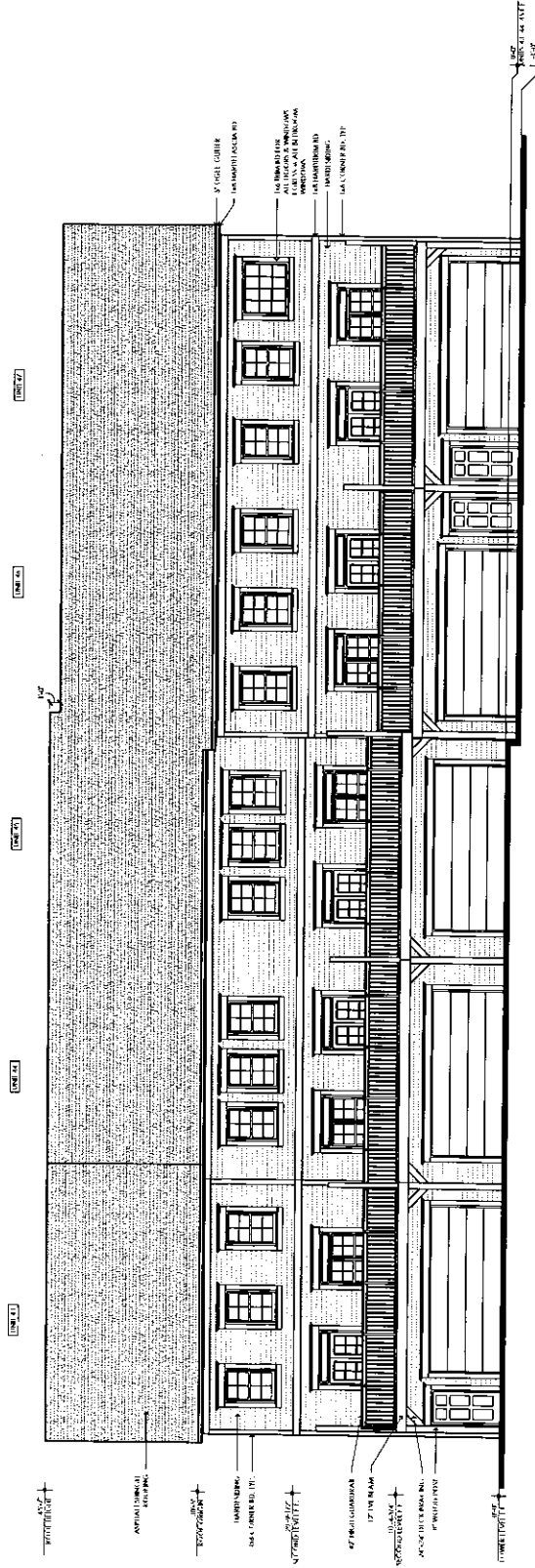

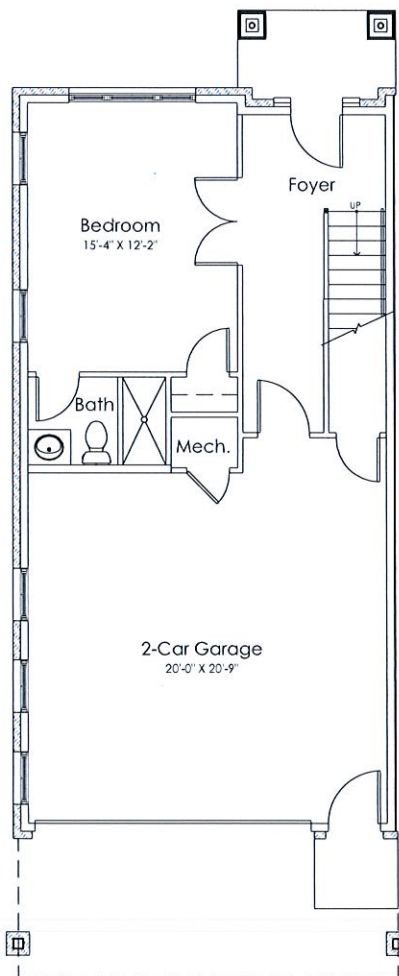
PROPOSED RIGHT SIDE ELEVATION

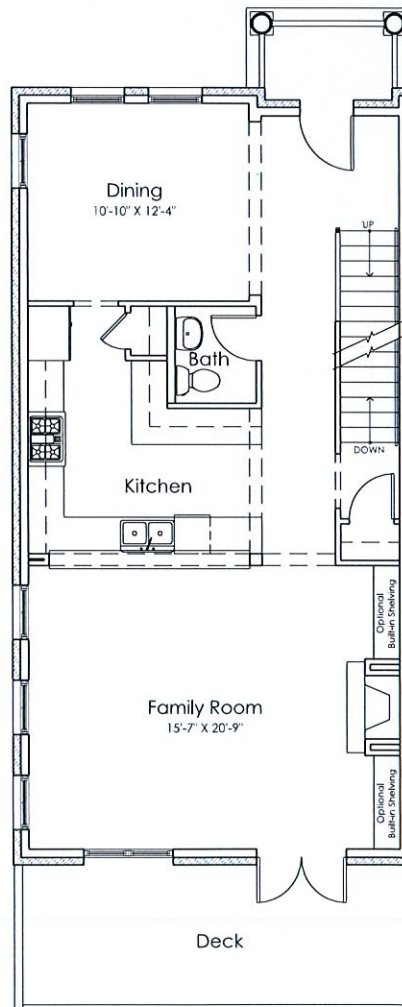
PROPOSED REAR ELEVATION

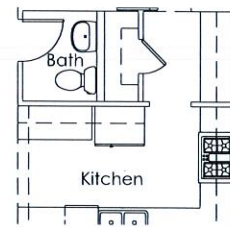
Ground Level
