Rusty,

As discussed with you this morning, please accept this email as a request on behalf of the Applicant to table the pending rezoning application from the City Council agenda of tonight, February 20th, to the City Council agenda for March 20th. While we have made significant progress on the sewer connectivity issue, there remain several issues which have been identified by the Wetherbrooke HOA.
