ISSUE:

Application for change of agent for privilege licenses for beer and wine (retail package) SF Markets LLC dba Sprouts Farmers Market #518. Paul Vincent Rohan was the previous agent and Billy Charles Jones, II is the applicant.

SUMMARY:

Billy Charles Jones, II as the registered agent for SF Markets LLC dba Sprouts Farmers Market #518 requests privilege licenses for the sale of beer and wine (retail package) at 4330 East-West Connector.

BACKGROUND:
