## CONTRACT TO CONDUCT CITY OF SMYRNA SPECIAL ELECTION FOR ALCOHOL REFERENDUM

This Agreement, entered into this	day of _	, 2018, by and between	the
City of Smyrna, Georgia (hereinafter "the	City") and Co	obb County, Georgia (hereinafter "	the
County"), witnesseth that:			

WHEREAS, the City has by Resolution on <u>July 16, 2018</u>, authorized a special election ("Special Election") to be called and held on Tuesday, **November 6, 2018** for the purpose of presenting a referendum to the voters of the City; and,

WHEREAS, the City has requested the County to perform the functions imposed by O.C.G.A. Section 21-2-45 with reference to such elections; and,

WHEREAS, the County is already conducting a General Election on November 6, 2018;

NOW, THEREFORE, in consideration of the sum \$1.00, and in consideration of the mutual covenants, promises, conditions and agreements contained herein, the parties mutually agree as follows;

- 1. **Payment for Costs:** The City agrees to pay to the County for the service of its Board of Elections and Registration in the conduct of the Election on Tuesday, November 6, 2018, all actual costs incurred in conducting the Election which are directly attributable to the cost of conducting the Special Election and not already attributable to the November 6, 2018 General Election.
- 2. **Duties of the County:** The County shall perform, through its Board of Elections and Registration, the following functions with reference to the conduct of the Election: (a) election planning; (b) ballot layout for absentee and provisional ballots; (c) hiring of personnel; (d) programming of election equipment; (e) preparation of electors list; (f) election day coverage; (g) election managers meeting; (h) auditing of election results; (i) certification and consolidation of returns; (j) absentee voting; (k) advance voting; (l) purchasing or renting of equipment, supplies, and facilities; (m) publishing any required Call or notice; (n) training of poll workers; (o) obtaining legal research and representation as necessary; and (p) such other reasonable and necessary duties and services as are required.
- 3. **Term:** This Agreement will begin on the Effective Date and shall continue until the conclusion of the Special Election, unless terminated by either Party with 30 days written notice. If the City terminates the Agreement, the City agrees to pay the County the actual cost incurred by the County in preparing for and/or conducting the Election through the date of termination.

- 4. **Indemnification:** To the extent permitted by law, the City hereby agrees to release, indemnify and hold harmless the County, its Board of Elections and Registration, and their Agents and employees from and against any and all loss, damage, injury, claims, expenses (including attorney's fees and expenses of litigation) and demands arising out of or connected in any way with the conduct of the Election, which are not occasioned by any gross negligence on the part of the County or its Board of Elections and Registration.
- 5. **Merger:** This Agreement states the full agreement between the Parties and supersedes all prior negotiations and agreements.
