SUBJECT: **Recommendation – 21-007 Early Replacement CIP Streets Department
Alamo Arm Mower**

The Public Works Streets department is requesting early replacement of an Arm Mower due to ongoing repair issues. The Budget office has approved adjustments to the FY2021 vehicle replacement schedule and will prepare a budget amendment if approved by Mayor & Council. The 2020 Alamo Arm Mower will be purchased from Flint Equipment in the amount of \$122,169.00 using the State of Georgia contract #99999-001-SPD0000102-0003 with Alamo Group. The equipment has already been competitively bid through the State of Georgia.

It is the recommendation of Public Works and Purchasing to purchase this equipment from Flint Equipment using the State of Georgia contract. Please prepare any necessary paperwork to present to Mayor and Council for approval.

The Public Works Department is requesting a change to its budgeted vehicle replacements in FY 2021. The department would like to early replace vehicle #3114 (2005 BUSH HOG – ARM MOWER) which is currently scheduled for \$36,000 in FY 2026. The department has solicited a quote (attached) for a replacement 2020 ALAMO ARM MOWER totaling \$122,169. The quoted price includes a trade-in allowance of \$10,000 for the old arm mower. To help fund this early replacement, the department would use funds from two vehicles budgeted for replacement in FY 2021.

- #6548 (2006 LEE BOY ROLLER) is budgeted for \$30,000. The department would push this replacement to FY 2024. The existing machine is in good condition, and no immediate repairs are needed.
- #5002 (2005 UD DUMP TRUCK – CHIPPER TRUCK) is budgeted for \$90,000. The department would surplus this truck and retrofit an existing quad cab truck to serve as the chipper truck. The department would purchase a removable bed box with R&M funds in the operating budget.

With a budget of \$120,000, the department would be \$2,169 short of the quoted price for the new arm mower. Since Public Works was under-budget for its FY 2020 vehicle replacements, the Budget Office has confirmed there are funds available to cover the small shortfall from this proposed early replacement.

The department is requesting that Mayor & Council approve these revisions to the FY 2021 vehicle replacement schedule and allow Finance to make the necessary budget amendment.
