All that tract or parcel of land lying and being in Land Lot 375 of the 17th District, 2nd Section, Cobb County, Georgia, being Lot 19, Block D, Belmont Hills, Unit One, as per plat of survey prepared for Jack Shinall, dated February 15, 1999 and prepared by Anastasios Costarides, G.R.L.S.
