generous spirit, LoveStreet school supply drive and not enough room. Helping
neighbors in need and he is very proud.
Wolfe Center open by appt. Museum open by appt as well.*

Mayor Derek Norton gave the following Mayoral Report:
He spoke about the good that came out of the pandemic. The state of emergency has been extended until September 10, 2020 by Governor Brian Kemp.
Support Smyrna has raised over \$175,000 to help their fellow citizens. No City employees has been furloughed during this time, to which he is very proud, and he remarked that the staff has given extraordinary customer service throughout, with no lapse to the citizens. Had thoughtful, peaceful protests in our City, where in other City's that had not been the case. The PD has worked with them to provide these opportunities. We have provided 15,000 meals with the help of the Tillman House, Wade's, Atkins and Zuccas. He is very proud of this town. This weekend Love Street had a school supply drive that was overwhelming.
Facility updates include the opening of the Wolfe Center and the pool to the public by appointment and the Museum resumes tours by appointment as well.

*Mayor Derek Norton made the following statement:
"This is an issue that we have been talking about for months. This City government has been very clear that discrimination has no place in the City of Smyrna and that this is a place that welcomes everyone.
We held a Town Hall last month to receive input from the public in which we allowed citizens to participate not only in person but over the telephone for those who did not feeling like they wanted to venture out in the pandemic environment. This is the first*

time in many years, if ever, that we have held a Town Hall to discuss a specific ordinance, because we wanted this to be fully vetted. We wanted to get this right and make sure that everyone had an opportunity to participate in the process. We also wanted to make sure that we avoided any unintended consequences. So with substantial input from all perspectives over several months I believe we have a strong ordinance and a very good process."

Attorney Scott Cochran gave the background for this item and the processes that he went through to provide the final version to be voted on this evening.

Councilmember Lewis Wheaton thanked the Mayor and City Attorney and members of the public for their thoughtful input. Additionally he thanked the other Councilmembers for their discussion and questions regarding same.

Councilmember Corkey Welch had a comment regarding his issue regarding the gender identity portion of this ordinance. He read aloud several news articles regarding the gender identity portion opening the door for individuals for abuse. He received an email from a constituent that hit home for him that read "...consider the end. The end is not tonight's vote, but down the road when there will be unintended consequence." He is unable to support this ordinance as written.

Councilmember Austin Wagner remarked and expressed his thanks as well to Mayor, City Attorney and citizen input. He thinks this Non Discrimination Ordinance is important to speak to for the City of Smyrna. This ordinance does not speak to the situations as read aloud by Councilmember Welch. We have laws that cover that and this ordinance does not make it easier for someone to engage in this type of criminal activity. He thinks the insinuation that trans gender individuals would be more likely to commit these types of crimes is inappropriate and incorrect. This ordinance speaks to what our values are.
