Approval of Ordinance ORD2020-20 - Annexation request (100% owners requesting annexation) - all tract or parcel of land lying and being in Land Lots 685 of the 17th District, 2nd Section, Cobb County, Georgia; a total of 0.83 acres, being known as 2021 Watkins Road, Smyrna, GA 30080, will be effective March 1, 2021 and part of Ward 7 and authorizes the Mayor to sign and execute all related documents.

**ISSUE AND BACKGROUND:**

The applicant, Anthony Andrew Jackson Henry, is seeking approval for annexation of approximately 0.83 acres, parcel number 17068500020 - all that tract or parcel of land lying and being in Land Lots 685, 17th District, 2nd Section, Cobb County, Georgia located at 2021 Watkins Road, Smyrna, GA 30080. Effective date March 1, 2021. Certified letters were sent by the City Clerk to the Cobb County Clerk's Office and the Cobb County Community Development Planning Division. The letter of non-objection from Cobb County was received on December 7, 2020 and this property will be located in Ward 7.
