<u>Public Hearing</u> - Variance Request - V19-015 - Allow west side setback reduction from 23 feet to 14 feet for an addition to a single family residence - Land Lot 451 - 0.20 acres - 922 McLinden Avenue - Preston Thomas

The applicant is requesting variances to reduce the side setbacks for the property at 922 McLinden Ave. The property is non-conforming in lot area and minimum house size. The applicant plans to construct an addition to the and requests variance to reduce the east side setback to 2 ft. and the west side setback to 14 ft. Section 801 requires setback in R-15 zoning district of 10 ft. for an internal side setback and 23 ft. for a side setback adjacent to a road. Explored being property is non-conforming with respect to lot area and minimum house size. The property is zoned R-15, which is a lot area of 15,000 sq. ft., while the subject property is 9,101 sq. ft. in area. R-15 also requires a minimum house 2,000 sq. ft. while the existing house is 971 sq. ft. Additionally, the subject property has an irregular shape as en runs to the north and west of the property. The applicant plans to construct an approximately 915 sq. ft. addition to sting structure. The additional area will convert the existing structure into a 3 bedroom/2 bath house. However, due to a conforming lot size and shape of the property, the applicant request variances on both side setbacks. This variance is leted with V19-014.

BACKGROUND: None.

MMENDATION/REQUESTED ACTION: The applicant is requesting to deviate from the development standards shed by the City for the side setback of 10 ft. and 23 ft. The applicant is requesting a variance to reduce the east side to 2 ft. and west side setback to 14 ft. to construct an addition to an existing home. According to Section 1403 of the

Ordinance, variances must be reviewed under the following standards: (1) Whether there are unique and special or dinary circumstances applying to the property; (2) Whether any alleged hardship is self-created by any person having rest in the property; (3) Whether strict application of the relevant provisions of the code would deprive the applicant of able use of the property; and (4) Whether the variance proposed is the minimum variance needed. Community pment has reviewed the request against the variance review standards and found it to be in compliance with four (4) four (4) standards. Similar variances have been approved throughout the city. At the time of this report, Community pment has not received any phone calls regarding the variance requests. After a review of the standards above, unity Development believes that the encroachment will not adversely affect surrounding residents; therefore, staff nends approval of the requested variance with the following conditions:

proval of the requested variance shall be conditioned upon the development of the property in stantial compliance with the site plan submitted with the variance application.

Downspouts and gutters be installed to divert stormwater away from adjacent property.

<u>REQUESTED ACTION</u>: The License and Variance Board hold a public hearing per Section 1400 of the Smyrna Code.
